RELEASE, PERMISSION AND INDEMNITY AGREEMENT

Waiver in consideration of being permitted to participate in any way in the March 29-31, 2017 TPPC Annual Member / Open Tournament ("the Tournament"), I, for myself, my heirs or assigns, do hereby release, waive, discharge and covenant not to sue the TPPC, its officers, employees and agents from liability from any and all claims resulting in personal injuries, accidents or illnesses (including death) and property loss arising from my participation in the Tournament.

Assumption of Risk participation in the Tournament carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary, but include 1) minor injuries such as bruises, sprains and dehydration, 2) major injuries such as eye injuries, joint, bone or back injuries, heat stroke, heart attacks and concussions, and 3) catastrophic injuries such as paralysis and death. Indemnify and hold harmless. I also agree to indemnify and hold the TPPC harmless from any and all claims, actions, suits, costs, expenses, damages and liabilities, including attorney fees brought as a result of my involvement in the Tournament.
